In consideration of the publication of the Article/Book, I hereby assign to the Institutes, during the full term of copyright and any extensions or renewals of that term, all copyright in and to the Article/Book.

In consideration of the publication, the Institutes will generally not provide any compensation to the Author except a complimentary offprint in the form of a pdf-file. The exception is 25 complimentary copies due to the Author(s) of a monograph, and 25 copies to the editor(s) of a multi-authored volume to be distributed among the authors of the individual articles.
